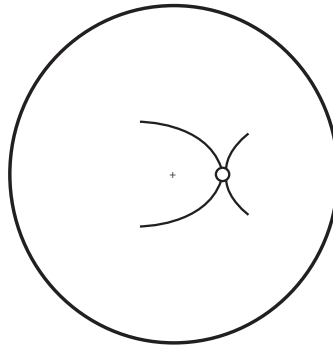

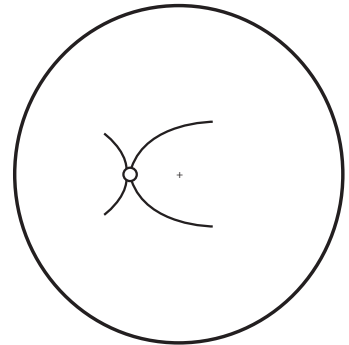

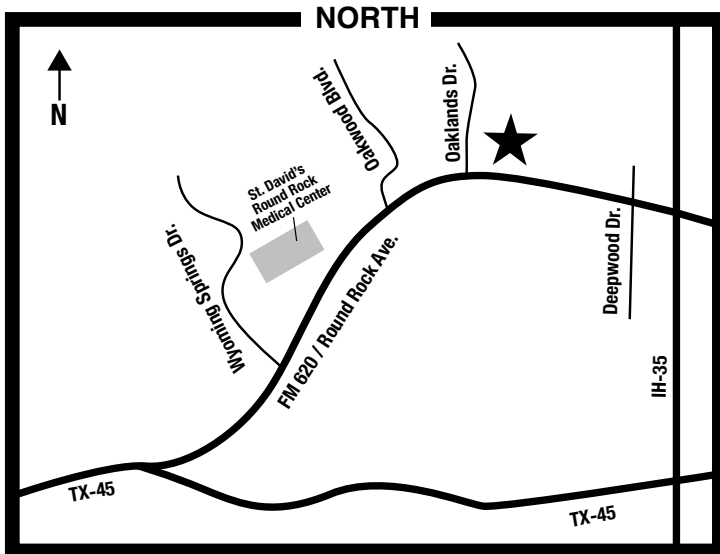

- If your insurance requires a referral, please request this from your primary care provider.

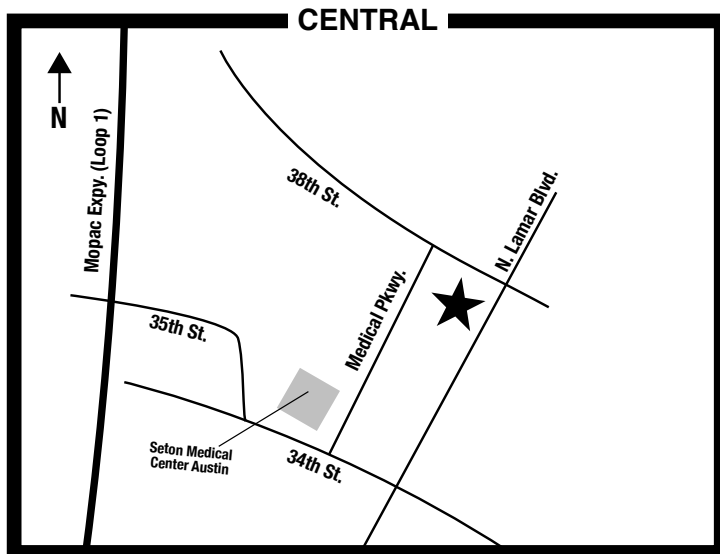

The office is located on the left after passing Oaklands Dr.

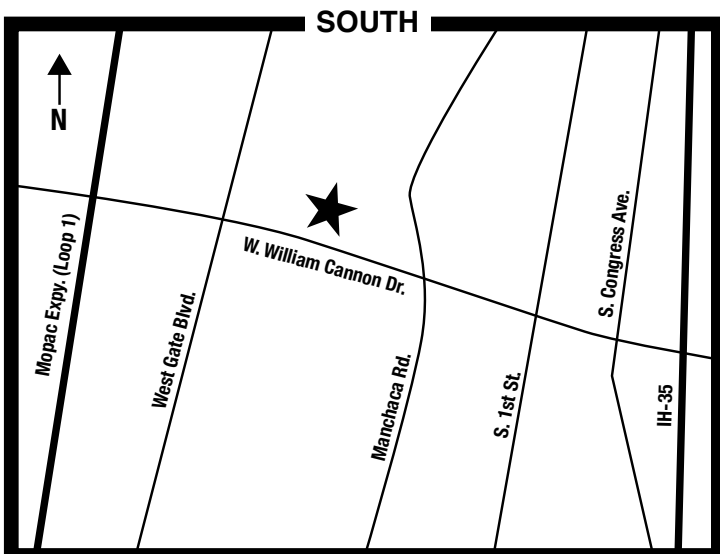
